Civil Service Memorandum Circular No. 07, 2020 re: "Interim Guidelines for Alternative Work Arrangements and Support Mechanisms for Workers in the Government for the Duration of the State of Public Health Emergency Pursuant to Proclamation No. 922".

**Date :** March 13, 2020

Pursuant to the above mentioned CSC Memorandum Circular No. 07, s. 2020 particularly paragraph 2.0, this office hereby issues the four-day Workweek schedule of Schools Division Office Personnel to take effect on Monday, March 16, 2020.

Non-teaching personnel assigned in school offices are also included to adopt this measure. While the school heads and teachers are required to report in school five days in a week until the end of the school year.

Schedule of the four-day workweek in school must be submitted to the SDO-Personnel Section. It is advised that the scheduled time shall be from 7AM to 6PM.
