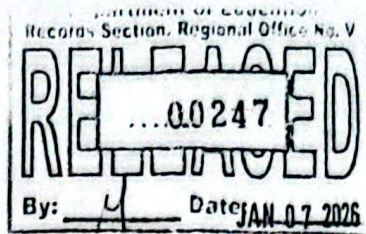

In compliance with DepEd Order No. 029, s. 2022 titled **Adoption of the Basic Education Monitoring and Evaluation Framework (BEMEF)**, this Office reiterates the provision that, *"In operationalizing the conduct of M&E, all operating units are required to develop M&E Plans for their respective education plans, programs, and policies. The M&E Plan is a document that guides the purpose and process of conducting monitoring and evaluation of any programs, policies, projects, office mandates, and activities."*

2. Relative thereto, all operating units in the RO and SDOs are mandated to establish a results-based M&E within their respective offices. Henceforth, all Schools Division Offices (SDOs) and RO-FDs/Sections/Units are hereby advised to submit their respective CY 2025 Implementation Plans and Monitoring and Evaluation Plans on the various programs and policies lodged at their respective Offices in this drive:
