Participants may opt to attend on official business. The activity is subject to the following conditions:

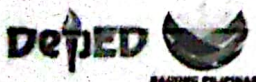


