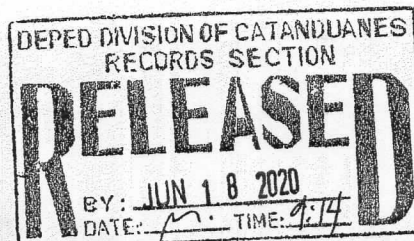

**DIVISION IMPLEMENTATION OF BRIGADA ESKWELA 2020
UNDER THE NEW NORMAL**

1. Consistent with DepEd Memorandum No. 53, s. 2020 entitled "Joint Implementing Guidelines on the 2020 Brigada Eskwela and Oplan Balik Eskwela Relative to the Covid-19 Situation" stipulates that Brigada Eskwela (BE) and Oplan Balik Eskwela (OBE) will be undertaken from June 1 to August 29, 2020 and shall be reconfigured to fully assist the preparation of stakeholders for the coming school year. The 2020 Brigada Eskwela activities shall highlight partnership initiatives that complement the Department's efforts

2. Pursuant to this, aside from the usual activities conducted in the past Brigada Eskwela, all School Heads shall take the lead in planning the activities geared on making schools virus free, ecologically conscious, resilient, clean, safe and conducive to learning. School Heads are requested to revise the submitted Brigada Eskwela Workplan integrating therein the suggested partnership engagement activities in the BE-LCP to wit:


- a. Coordination with the LGU's or other NGO's in the disinfection of schools;
- b. Mobilization of essential items such as thermal scanners, hand sanitizers, foot baths, face masks/shields, gloves, multivitamins, hygiene kits, and printing materials, school supplies for remote learning etc.;
- c. Conduct of psychological first aid or other psychological interventions;
- d. Orientation activities with teachers, partners and PTA on DepEd's Learning Continuity Plan (LCP);
- e. Implementation of Gulayan sa Tahanan and Urban Vegetable Gardening at Home;
- f. Updating of school emergency and contingency plans
- g. Other school-based initiatives
- h. Enriching Partnership Appreciation

3. The activities mentioned above highlight partnership initiatives that complement the Department's efforts to ensure that quality education will continue despite the challenges encountered in adapting to the new normal.
4. Partnership engagement activities, if face to face is allowed, shall strictly comply with protocols on social distancing and implement precautionary measures consistent with the IATF health protocols, DOH protection protocols, local quarantine rules and all other relevant protocols outlined in DepEd and DepEd Task Force Covid-19 issuances.
5. School Heads with the assistance of the BE Coordinators, teaching and non-teaching personnel should advocate Brigada Eskwela 2020 through different platforms and mobilizing needed resources.
6. Brigada Eskwela Monitoring Teams created by this Office shall visit the schools to ensure its implementation. The teams shall be assisted by the PSDSs/In-charge of the districts and District BE Coordinators.
7. The revised BE School Workplans must be submitted to this Office through the SGOD - Social Mobilization and Networking Unit the soonest possible time. Attached is the Revised 2020 Brigada Eskwela Consolidated Report Template. Please provide the summary/consolidated report for the SCHOOL/DISTRICT (Summary for Elem, Sec and ALS); **Summary Report** shall be submitted at the end of each month (**last working day of each month**), starting June, and the **Complete Report on September 15, 2020**;
8. Travel and incidental expenses of the members of the monitoring teams and BE Coordinators involved shall be charged against Local Funds/MOOE subject to the usual accounting and auditing rules and regulations.
