- 1. Pursuant to Regional Memorandum No. 000300, s. 2024 dated March 11, 2024, a RASSEAE Regional Accreditation for Officiating Officials and Coaches of Volleyball shall be conducted on March 22-24, 2024 at Legaspi City.
