The Department of Education (DepEd) Schools Division Office of Catanduanes through the Curriculum Implementation Division (CID) Alternative Learning System (ALS) announces the conduct of the Division Presentation Portfolio Assessment (PPA) for ALS Accreditation and Equivalency Elementary and Junior High School Learners for the School Year 2025-2026.

2. The Presentation Portfolio Assessment (PPA) is required for ALS learners to qualify for the 2025 Accreditation and Equivalency (A & E) Test. PPA shall be conducted prior to the administration of A & E Test. Only the registered applicants with complete requirements and who have passed the Presentation Portfolio Assessment (PPA) shall be allowed to take the A & E test at the testing centers duly approved by the Bureau of Education Assessment (BEA).
