- 1. Pursuant to DepEd Order No. 36, s. 2016 titled Policy Guidelines on Awards and Recognition, DepEd Order No. 18, s. 2021 titled Interim Guidelines on Giving Awards and Recognition in Light of Basic Education Learning Continuity Plan for School Year 2020-2021, DepEd Order No. 43, s. 2022 titled Conduct of the K to 12 Basic Education Program End-of-School Year Rites for School Year 2021-2022 in the Light of COVID 19 Public Health Emergency and DepEd Order No. 21, s. 2022 titled Extending the Effectivity of DepEd Order No. 18, s. 2021 to School Year 2021-2022 and Amending Certain Provisions Thereof, this office issues the following guidance for the information and compliance of all concerned.
  - 1.1. The last day of school or classes shall be June 24, 2022.
  - 1.2 The date of graduation, completion, moving up shall be the actual date of the rite/s which is between June 27 and July 2, 2022.
