

- 5. On the division level, participating schools will submit a CD or USB or upload via Google Drive the compilation of the school's best practices in Power point presentation maximum of 50 slides with photos, videos and narrative report of their implementation to the Division Supervisor/Wellness Ambassador in charge of the Program. The division supervisor and GTI will agree on the deadline of the submission of the presentation and the date of judging. See "Annex A" for the content of the power point presentation.
- Based on the presentation submitted, the division supervisors in charge, together with the GTI representatives, will judge and select the division winners based on the criteria. Only the champion schools in elementary and high school will represent the division to the regional level.
- 7. On the regional level, all division winners will submit an enhanced Power point presentation of their best practices in maximum of 50 slides with photos, videos and narrative report of the implementation of their best practices to the ESSD chief or to his/her duly assigned representative. Deadline of submission and judging of entries will be announced accordingly.
- Based on the presentation submitted, the judges from DepEd Regional office and GTI/ NPI will determine the regional winners based on the set criteria. The regional winners will represent the region to the national level.
- On the national level, winners will be determined based on the enhanced presentation submitted via CD, USB or Google Drive with the mode of verification via CD or USB. The schools with the highest scores will be recognized as the "S.Y. 2021-2022 Nestlé Wellness Campus Best Implementing School."
