- 1. Per reference to DepEd Order no. 39 s. 2005, a joint CHED and DepEd Memorandum Order re: Guidelines on Deployment of Student Teachers, states that Teaching or Teaching Internship is one of the most and crucial phases in Teacher Education. It is in this culminating stage where the student teachers put into practice the learning competencies, they have acquired in the teacher education program and at the same time harness their teaching competencies.
- 2. At this point, cooperating teachers play a crucial role in mentoring and coaching the pre service teachers considering that they provide assistance/ support to pre- service teachers in terms of pedagogical knowledge and instructional skills.
