2. The reading assessment's main goal is to identify children who need additional support in reading.

3. Participants to this activity are the grade one to three key teachers and school heads in each district for the CRLA and the BLIT who can best represent all subjects in English, Filipino, and the Mother Tongue, recommended by the Public Schools District Supervisors. Each district is allocated one slot for a key teacher another slot for the key school head.

4. The said activity will be done on a limited face to face training - workshop, strictly following health and IATF protocols. Participants are advised to bring laptop, hard drive and gadgets for workshop purposes.

5. Relevant to this, a Division Staff Orientation Workshop (DSOW) of all facilitators will be held on September 24, 2021 in a venue to be announced later.
