PROCUREMENT OF BOND PAPER (A4 size, S-20)

For the Reproduction of Self-Learning Modules for Quarter 2

- The Schools Division Office of Catanduanes, through the General Appropriation Act (GAA) CY 2020 intends to apply the sum of Nineteen Million Five Hundred Ninety Nine Thousand Eight Hundred Pesos Only (P19,599,800.00), being the Approved Budget for the Contract (ABC) to payments under the contract for the Procurement of Bond Paper for the Reproduction of Self-Learning Modules for Quarter 2. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Schools Division Office of Catanduanes now invites bids for the Procurement of Materials for Module Reproduction for Quarter 2. *Delivery of the Goods is required within thirty (30) days*. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II Instruction to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

- 4. Interested bidders may obtain further information from *DepEd*, *Division of Catanduanes*, *BAC Secretariat* and inspect the Bidding Documents at the address given below from <u>8:00 A.M. to 5:00 PM</u>.

- 8. Prior to Bid Opening, representative of bidders should present and submit to the BAC a **Special Power of Attorney** stating the detailed activities which he/she will perform relative to the bidding at hand.
- 9. The *Schools Division Office of Catanduanes*, reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
