RESOLUTION URGING THE PROVINCIAL GOVERNMENT AND ITS ELEVEN (11) MUNICIPALITIES TO CLOSELY MONITOR THE IMPLEMENTATION OF THE SUPPLEMENTAL FEEDING PROGRAM (SFP) FOR DAY CARE CENTERS AND SCHOOLS TO ALLEVIATE MALNUTRITION IN THE PROVINCE

WHEREAS, the state recognizes the vital role of the youth in nation-building and shall promote and protect their physical, moral, spiritual, intellectual, and social well-being;

WHEREAS, Republic Act No. 11037 otherwise known as "Masustansyang Pagkain para sa Batang Pilipino Act" institutionalized a national feeding program for undernourished children in public day care, kindergarten, and elementary schools to combat hunger and under nutrition among Filipino children with appropriation of funds;

WHEREAS, Section 2 of RA 11037 states the recognition of the demonstrated relationship between food and nutrition and the capacity of students to develop and learn;

WHEREAS, there is still a considerable number of malnourished children and students in the Province of Catanduanes;

WHEREAS, Section 7 of R.A. 11037 states that the LGUs are obligated to assist the National Government Agencies (NGA's) in the efficient and effective implementation of the program in accordance with Section 4 of R.A. No. 11037 and shall be authorized to use portion of the Special Education Fund (SEF) and/or their 20% development fund as provided for in Republic Act No. 7160 otherwise known as the "Local Government Code of 1991", as amended, to augment the appropriations available under the General Appropriations Act (GAA);

NOW, THEREFORE, on motion of the Hon. Robert A. Fernandez and duly seconded by Hon. Natalio C. Popa, Jr., be it

RESOLVED, AS IT IS HEREBY RESOLVED, to urge, as it is hereby urged, the Provincial Government and its eleven (11) municipalities to closely monitor the implementation of the Supplemental Feeding Program (SFP) for Day Care Centers and schools to alleviate malnutrition in the province;

RESOLVED FINALLY, that copies of this resolution be furnished the Acting Provincial Governor, Hon. Shirley A. Abundo, and all Municipal Mayors in this Province, the Schools Division Superintendent, Dr. Danilo E. Despi, CESO V, Department of Education, Division of Catanduanes, Virac, Catanduanes, the PSWD Officer, Ms. Ma. Rosella N. Taraya, Provincial Social Welfare and Development Office, this province, for information and appropriate action.
