INVITATION TO BID

Provision and Distribution of Nutritious Food Products (NFP) and Milk Feeding (MF) for the Implementation of School-Based Feeding Program (SBFP) for SY 2023-2024

1. The Schools Division Office of Catanduanes through the General Appropriation Act (GAA) SY 2023-2024 intends to apply the sum of Twenty Million Three Hundred Eighty Two Thousand Seven Hundred Eighty Pesos Only (Php20, 382,780.00), being the Approved Budget for the Contract (ABC) to payments under the contract for the procurement of Provision and Distribution of Nutritious Food Products and Milk Feeding Component for School Based Feeding Program (SBFP) SY 2023-2024. Bids received in excess of the ABC shall be automatically rejected at bid opening.

- 84 days for Nutritious Food Product (NFP)
- 30 days for Milk Feeding (MF)

MENU:

- 1. Attached on a separate paper is the 20 days (1 month) Cycle Menu for 84 days of NFP and 30 days for MF.
 - a. The **DOST-FNRI NFP Enhanced Nutribuns** must be of 120-160 grams each per pack or 60-80 grams x 2 pcs. for every beneficiaries.
 - b. The **Eggs** to be delivered must be fresh and of XL size of 2 pcs. per beneficiary each day of its scheduled feeding day.
 - c. The **Nutri-packs** (flavours and pieces as specified in the cycle menu) is of 60-100 grams per pack.
 - d. The **Nutri-cookies and Rice Bar** (flavours and pieces as specified in the Cycle Menu) is 60 grams and 25 grams per pack simultaneously.
 - e. The **Iron Fortified Rice (IFR)** is 350 grams per serving (raw and uncooked).
 - f. The Milk Feeding Component shall be commercially available ready to drink Chocolate Milk Drink Pack of 110ml pack.

FOOD PACKAGING AND REPLACEMENT

- 1. All Nutritious Food Products that needed to be distributed must be hygienically packed in environment-friendly bag with clear and readable tags that indicate the **Manufacturing date and** the **Expiration Date** for each product:
 - a. **Nutribuns** Expiration Date should be at **least 5 days** from the date of delivery to schools.
 - b. Eggs- If school inspectorate team received the eggs broken or with any indication of none-freshness, this must be reported as soon as possible for replacement.
 - c. Nutri-packs-Expiration Date should be at least 6 months from the date of delivery to schools.
 - d. Nutri-cookies and Rice Bars- Expiration Date should be at least 5 days from the date of delivery to schools.
 - e. Iron Fortified Rice (IFR)- Expiration Date should be at least 6 months from the date of delivery to schools.
- 2. Any signs of discoloration, molds or deformities (especially on the nutribuns, nutri-cookies and rice-bars) must be reported to the SHNU and supplier for change of product/s and these must be replaced by the supplier within 5 days of its receipt in the school.
- 3. During the repacking of NFP and milk component, personnel must adhere to the food safety standards such as handwashing before the handling the food products, wearing of mask, gloves, face shield, hairnet and practice of physical distancing.

SCHEDULE OF DISTRIBUTION/DELIVERY

- 1. The delivery of Nutritious food products will be TWICE a week:
 - a. Every **Monday for the first 2 days** (Monday and Tuesday deliveries, except for Nutripacks)
 - b. Every **Wednesday for the next 3 days** deliveries (Wednesday to Fridays, with Nutripacks) to supply for the total of five (5) days Or 1 week.
 - c. For **Milk feeding**, it will be a **one-time delivery only**. Distribution time will be from 8:00 12:00 noon on a scheduled period per municipality.
- 2. The Nutribuns, Nutri-cookies and Rice Bars will be served to beneficiaries in school as snacks with the Milk products, while the IFR, Nutri-packs and Fresh Eggs shall be packed together by the supplier (and will be delivered on Wednesdays), will be given to the beneficiaries by the school, to be served or eaten at home.

IMPLEMENTATION

- 1. The implementation of the School-Based Feeding Program for SY 2023-2024 will start on OCTOBER 2023 (specific dates to be announced), to cover:
 - 84 days for Nutritious Food Products (NFP) and
 - 30 days for Milk Feeding (MF)
- 2. Table 1 shows the following tentative schedule of feeding days for the NFP and MF component.

TERMS OF REFERENCE:

1. SCHOOL PERSONNEL

- a. School Heads (SH), School-Based Feeding Coordinators (SBFC) and School Inspection Team will receive the NFP and Milk.
- b. **School Inspection Team (SIT)** will ensure that the delivered NFP and Milk are according to their specifications as to quality and quantity. They will accomplish 3 copies of the following reports (1 for submission with the Program Terminal Report (PTR), 1 for SGOD-SHN and 1 for school file):
 - Acknowledgment Receipt Form (AR);
 - Inspection and Acceptance Report Form (IAR)revised form (Quantity, Quality);
 - Distribution List for signature of parents/guardians of the beneficiaries

These forms shall be submitted after the end/last day of feeding together with the Program Terminal Report (PTR) c/o School Health Section.

- c. The SH and SBFCs, upon inspection and acceptance of food packs and milk, are responsible for making sure that they will be distributed immediately to the specified beneficiaries. In case the delivered NFP and Milk does NOT meet the specifications, the SH, SBFC and SIT SHALL NOT ACCEPT it. The schools then shall inform within the day the Supplier and Division Program Coordinators: Ma. Theresa G. Abundo (CP#09204833497) and Jennifer S. Casallo (CP#09208169533).
- d. The SIT has the right to demand from the delivery personnel to countercheck the food packs and milk before signing in the AR, IAR.

2. SUPPLIER:

- a. It is the responsibility of the supplier to deliver the Nutritious Food Product and Milk in accordance to its specifications as to the nutrition value, quantity and quality and food packaging with expiration date.
- b. The delivery to schools of the SBFP MF products will be at 8:00 AM 12:00 Noon as per schedule of distribution.
- c. The winning Supplier will deliver the nutritious food products and milk feeding component to **Schools as drop-off points.**
- d. The supplier must provide a copy of the Acknowledgement Receipt (AR), Inspection and Acceptance Report (IAR) and a Delivery Schedule per school for signature of the SIT or SH or the SBFC. He must also give a copy to the SDO SHN Office every Friday of the delivery week as proof for the week's completion of the delivery.
- e. The Supplier shall ensure that the number of goods to be delivered is complete. In case of discrepancy in the actual delivery, the Supplier is responsible to complete the expected number of delivery **within 5 days.**
- f. The supplier must also make available to the schools a **contact number** of the delivery personnel, and must be ready for any queries or concerns of the schools regarding delivery schedule/routes.
- g. The supplier is the responsible entity in the distribution of food packs to the designated drop off points (schools) from 8:00 AM to 12:00 PM, until all products are received by each schools.
- h. Food packs and milk must be placed on a clean, elevated (at least 15 cm or 6 inches) safe containers/storage box to avoid spoilage.
- i. Supplier's packaging site must be clean, safe, pest free, with handwashing area, thermal scanner, alcohol and personnel must adhere to food safety standards like wearing of facemasks, gloves, hairnet, practice of physical dispensing and of good grooming.

INSPECTION AND MONITORING

a. Monitoring activities maybe done using the available and appropriate technology including online platforms such as Google Sheet (SBFP Monitoring Summary), video conferencing, facebook workplace group or chats, real-time monitoring like taking photos or streaming live videos of the actual implementation of the program, feedbacks from learners and parents, appropriate correction of practices and recommendation shall be integrated in the SBFP Terminal Report.

- b. The Division Inspection Team (DIT) for food/goods shall conduct the inspection, with the assistance of assigned School Health and Nutrition (SHN) personnel. A DIT Inspection Report is also expected within 3 days of inspection, and a copy must be given to the SGOD SHN team within the same period.
- c. Schools shall document the receipt of food items by the parents/guardians and learners for all deliveries made.
- 3. The Schools Division Office of Catanduanes now invites bids for the above Procurement Project. Delivery of the Goods is required Eighty Four (84) days for Nutritious Food Products and Thirty (30) days for Milk Feeding. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II Instruction to Bidders.
- 4. Bidding will be conducted through open competitive bidding procedures using non-discretionary *pass/fail* criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
- 5. Prospective bidders may obtain further information from Schools Division Office of Catanduanes and inspect the Bidding Documents at the address given below during Monday to Friday from 8:00 AM to 5:00 PM.
- 6. A complete set of Bidding Documents may be acquired by interested Bidders on August 10 to 30, 2023 from the given address and website below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Twenty Five Thousand Pesos Only (Php25,000.00). The Procuring Entity shall allow the bidder to present proof of payment for the fees in person.
- 7. The Schools Division Office of Catanduanes will hold a **Pre-bid Conference** on **August 17, 2023 at 2:00 PM** at **SDO-CID Office** which shall be open to prospective bidders.
- 8. Bids must be duly received by the BAC Secretariat through manual submission on or before **August 30, 2023 at 9:00 AM at CID Office**. Late bids shall not be accepted.
- 9. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 10. Bid opening shall be on August 30, 2023 at 9:00 AM at CID Office. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

- 11. Prior to Bid Opening, representative of bidders should present and submit to the BAC a **Special Power of Attorney** stating the detailed activities which he/she will perform relative to the bidding at hand.
- 12. The Schools Division Office of Catanduanes reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.


