- Pursuant to DepEd Memorandum No. 153 s.2013, entitled," National Training of Trainers on Child Protection" and DepEd Order No. 40 s.2012, entitled," DepEd Child Protection Policy", this division shall conduct a Division Training on Child Protection for both teaching and non-teaching personnel.
- 2. This training aims to build the capacities of school officials, personnel, pupils, students, and parents to understand and deal with child abuse, exploitation, violence and discrimination cases, bullying and peer violence.
- 3. Specifically, this training shall:
 - a. enhance social and emotional competencies of the participants in handlingchildren;
 - b. be able to adapt measures to protect children from all forms of abuse, exploitation, violence, discrimination and other related cases.

The Opening program shall include only the most important numbers such as the singing of the national anthem, a prayer presentation of participants, welcome remarks from the host school/district, and community singing.
- 9. Travel and other expenses of the training team and the participants which will be incurred during the roll-out of this training shall be charged to division/local, INSET, MOOE, or GAD funds subject to the usual accounting rules and regulations.
