1. In line with the Department of Education's initiatives to institutionalize the Healthy Learning Institutions (HLI) Framework and to ensure the provision of a safe, healthy, and supportive learning environment, all concerned are hereby directed to accomplish and submit the Healthy Learning Institution-Self-Appraisal Checklist (HLI-SAC) for School Year 2025-2026.
2. The objectives of the HLI-SAC validation is to:
  - Assess the school's performance and practices across the six (6) HLI Pillars through systematic self-appraisal;
  - Support effective planning and decision-making by identifying strengths, gaps, and priority areas for school health interventions; and
  - Promote a safe, healthy, inclusive, and supportive learning environment for learners, personnel, and stakeholders.
3. The accomplished HLI-SAC shall be organized into six (6) folders, corresponding to the six (6) Pillars, as follows:
  1. Pillar 1: Healthy School Policy
  2. Pillar 2: Physical Environment
  3. Pillar 3: Social School Environment
  4. Pillar 4: Health Skills and Education
  5. Pillar 5: Links with Community
  6. Pillar 6: Access to Healthcare
4. Each folder must contain the completed checklist and all relevant Means of Verification (MOVs) to support the responses indicated in the HLI-SAC. All documents should be properly labeled, arranged, and ready for validation.
