## 2016 METROBANK - MTAP-DEPED MATH CHALLENGE (ELEMENTARY LEVEL)

- Pursuant to DepED Memorandum No. 141, s. 2015 re: 2016 Metrobank- MTAP-DepEd Math Challenge, this division will conduct the 2016 Metrobank-MTAP-DepEd Math Challenge for Elementary Level by Municipality which will be held simultaneously on January 14, 2016.
- 2. The over-all objective of the competition is to contribute in improving the quality of mathematics education in the Philippines. Specifically it aims to:
  - a. awaken greater interest in mathematics among elementary pupils in both public and private schools;
  - b. encourage pupils to strive for excellence in Mathematics;
  - c. encourage them to master the basic mathematical skills;
  - d. discover mathematical talents among the pupils
  - e. develop the values of hard work, perseverance, honesty, teamwork and sportsmanship;
  - f. provide them with opportunities in leadership and cooperative undertaking.
- 3. The elimination round will be conducted on the following venues:

- 4. Each principalship/head teachership school will send three (3) contestants per grade level.
- 5. The Division Special Science and Mathematics Class (DPSSMC), JMAMES SPED Center, CSC Laboratory School, Ville St. John School, Dr. Guillermo Reyes Adventist School, STAR Learners School and SILOAH are allotted three (3) contestants each per grade level.
- 6. The participants will report to their respective venue at 7:30 a.m. of the scheduled date.
- 7. The host principal is requested to conduct a short opening program, do preparation of the contest venue/hall and the registration sheets by grade.
- 8. The PSDSs who are assigned as Testing Center Coordinators are required to claim the testing materials from the Division Math Supervisor on January 13, 2016. However, the test materials shall be opened publicly by the Testing Center Coordinator just before the start of the competition.
- 9. The list of Testing Center Coordinator, Room Supervisors, number of examinations rooms and examiners (to be assigned by concerned PSDS) and mechanics for the elimination round together with the guidelines for proctors are enclosed for the guidance of all concerned.
- 10. The assigned Room Examiners are asked to check the answer sheets right after the test using the answer keys provided. Answer Keys shall only be opened just before the correction begins.

- 11. The Testing Center Coordinator are required to submit on January 14, 2016 p.m. the following Consolidated Report by grade level.
  - a. Individual Results of contestant
  - b. School's score obtained from the sum of the top two scorers.
- 12. All public and private schools are required to accomplish a one-page registration form (MMC Form No. 1) which should be submitted on the scheduled elimination round to the Coordinator of the testing center who will turn-over the registration forms to the EPS In-Charge of Mathematics.
- 13. The district supervisors, school heads and mathematics teachers are requested to actively campaign and enjoin support for the competition of all public and private Elementary schools in this division.
- 14. The travel expenses in the participation to this activity are chargeable to the school MOOE subject to the usual auditing and accounting rules and regulations.

15. Immediate and wide dissemination of this memorandum is desired.
