- 1. In relation to the Grant of Performance-Based Bonus FY 2021, you are hereby advised to submit the prescribed and updated FY 2021 PBB Form 1.0- List of Eligible and Non-Eligible Personnel. Copy of PBB School Level Form 1.0 can be downloaded from https://bit.ly/PBBF1
- 2. Pursuant to DepEd Order No. 007, s. 2021, please be guided by the following individual eligibility in filling out PBB form 1.0:
  - a. An official or employee who has rendered actual service from July 25, 2021-July 31, 2022.
  - b. Monthly Basic Salary Grade and Steps as of December 31, 2021
  - c. An official or employee who has rendered a minimum of nine (9) months of actual service during the current rating period and with at least "Satisfactory" performance rating may be eligible for the full grant of the PBB.
  - d. An official or employee who rendered less than nine (9) months but a minimum of three (3) months of actual service and with at least "Satisfactory" performance rating may eligible for the grant of PBB on a pro-rata basis corresponding to the actual length of service rendered.
  - e. The grant of the PBB on a pro-rata basis shall only be applicable for the following valid reasons:
    - a. Newly hired employee
    - b. Retirement
    - c. Resignation

- d. Rehabilitation Leave
- e. Maternity Leave/Paternity Leave
- f. Vacation or Sick leave with or without pay
- g. Scholarship/Study Leave
- h. Sabbatical Leave
- i. Special Leave for Women (Magna Carta for Women)
- j. Parental Leave (Solo Parent Welfare Act)
- f. An employee who is on vacation or sick leave with or without pay for the entire year shall not be eligible for the grant of PBB.
- g. An official or employee who failed to submit the 2020 Statement of Assets, Liabilities and Net Worth (SALN) shall not be entitled to the PBB.
- h. An official or employee who failed to liquidate all Cash Advances received in FY 2021 within the reglementary period shall not be entitled to the PBB.
- i. An official or employee who failed to submit the OPCRF/IPCRF for the rating period of 2021-2022 on or before the deadline set by the HRMO shall not be entitled to the PBB.
- 3. Deadline for submission of accomplished PBB form 1.0 for Elementary and Secondary **not later than February 21, 2023 (Tuesday)** thru the following link:

- **4.** To ensure the complete list of eligible school-based personnel, Administrative Officers assigned to elementary are requested to review and consolidate the said report. Consolidated reports should be submitted **on or before Thursday, February 23, 2023.**
