



What is CUPSCON?


The Colleges and Universities Public Service Conference (CUPSCON) is organized by the UP Padayon Public Service Office. It is a three-day conference which Padayon organizes every two years. CUPSCON is platform for sharing best practices, innovative and collaborative approaches in public service, and discussing challenges and trends in public service. Conference participants are from various Higher Education Institutions (public and private), government agencies, local government units, civil society organizations, and even the private sector.

Now in its 5th year, this iteration of the conference marks the first time Padayon will collaborate with an SUC, specifically with **Palawan State University**, in bringing together various stakeholders engaged in public service. It will also be the starting point for the launch of a **Public Service Consortium** to be spearheaded by Padayon together with PSU and other participating institutions and organizations.

In 2021, CUPSCon garnered recognition and won the Silver Anvil Award during the 56th Anvil Awards of the Public Relations Society of the Philippines. The said award represents high standards met by the UP program in the category "public relations programs carried out on a sustained basis" for urban or rural community development.

CUPSCON5 Theme: "The Future of Public Service in the Fourth Industrial Revolution: Trends, Challenges, and Prospects."

With the disruptions caused by the COVID-19 pandemic, there was an unprecedented shift towards the rapid adoption and use of digital technologies in many sectors, including education and public service. For instance, academic institutions were forced to adopt innovative learning



strategies, including digital and non-digital teaching modalities, to ensure the seamless delivery of quality education during the pandemic. Meanwhile, the alarming rise in mental health issues among the youth has compelled several groups to offer online counseling services due to the prolonged periods of quarantine, isolation, and uncertainty. The use of digital technologies in public service was seen as crucial and goes beyond the circumstances during the pandemic. As we aspire towards the full integration of technological innovations in public service delivery, the government, industry, and the academe should synergistically resolve the increasing number of challenges that come with it and ensure inclusive, human-centered, and pro-people development prospects.

The fifth installment of the Colleges and Universities Public Service Conference shall highlight the public service initiatives research and best practices on the adoption and use of technological innovations, before, during, and after the pandemic, of public and private Higher Education Institutions from local and international universities and colleges, Government Offices (GO's), Non-Government Organizations (NGOs), Civil Society Organizations (CSOs), Companies and private sectors with corporate social responsibility; and Local Government Units.
